



#### 4.Youth Empowerment Projects:

 Collaborated with Youth RISE on the EU Drug Policy Training Series for young people, amplifying the voices of young people in the drug policy movement and promoting youth-led initiatives.
Organized regional conferences and networking events, fostering collaboration and knowledge-

sharing among youth advocates.

# EU Drug Policy Training & Strategy Series

This project aimed to increase the capacity of youth-led organizations that engage in drug policy reform and to empower young people to advocate at the European Union level. Recognizing that the protection of young people is often cited as one of the primary goals of drug policies, it was deemed essential for the youth voice to be present in drug policy creation and implementation processes. Young people who use drugs were identified as a particularly vulnerable population due to their dependence on families or the government for financial stability, housing, and education. As such, it was critical that policies intended to protect youth were influenced by the insights that youth held about drug use.

To achieve the goal of increasing the capacity of youth-led organizations and young people to engage with EU drug policy, a training series was organized. This series equipped young people with the necessary knowledge, skills, connections, and strategy to engage with the EU Drug Policy Creation process and create a youth-led dialogue around EU drug policies.


This training had the dual outcome of increasing the capacity of individuals and organizations to meaningfully engage with EU Drug Policy.

### The project had four objectives:

- 1. **Knowledge Building:** To build a base of knowledge regarding how the EU makes decisions about drugs and the historical context of drugs in EU policy.
- 2. **Skills Building:** To build a base of advocacy skills tailored to the EU context.
- 3. **Connections:** To build connections between young people and key stakeholders in EU drug policy (i.e., EU Decision Makers, Civil Society, and Youth).
- 4. **Strategy Building:** To bring the youth participants together to strategize on how they would further the youth voice in EU Drug Policy.

These four objectives informed the stages of the project. Following a preparation phase, the project began with three knowledge-building workshops focused on the EU Drug Policy Creation Process, the History of EU Drug Policy, and the Current Drugs Strategy. These workshops ran between September and October 2022, and participants had the opportunity to hear firsthand how policy develops in EU institutions from Panel Representatives from EMCDDA and the Civil Society Forum.







# UN Advocacy & Training Series

35 participants took part in the training series which included introductory sessions, civil society best practices, public speaking and networking session.

### **Commission on Narcotic Drugs**

We had a delegation of 6 people from 5 different countries. We held a side event, made a statement in the main session, participated in 3 informal dialogues and met with multiple country delegations.






### Youth Advocacy

## Support. Don't Punish Initiative: Advocacy Outreach to YPWUD in West Africa

#### **Project Description**


As part of the Support. Don't Punish Initiatives Grant, we have developed this project aimed at addressing two of the challenges faced by Young People who Use Drugs in low-income areas in Liberia, Ghana & Nigeria. 1. YPWUD in these regions have little, if not no, access to drug-related services, let alone youth-accessible drug services, and 2. YPWUD in this region faces extremely high barriers to accessing advocacy spaces. The project consists of direct harm reduction outreach activities and focus group discussions to collect information on the needs of this population. Furthermore, the project aims to link participants with local actors involved in drug policy reform advocacy and harm reduction services.

All three countries are prepared for activities and will be commencing them this month.
